1. CALL TO ORDER:

Chair Illingworth called the regular meeting of the Social Services Commission to order at 6:34 p.m. on September 6, 2022.

2. ROLL CALL

3. PLEDGE OF ALLEGIANCE

Commissioner Luevano led the Pledge of Allegiance.

4. PUBLIC COMMENTS

No public comments were received.

5. OATH

Oath of office was administered to Benito Guerrero Jr. Oath of office was administered to Irene Muro

6. STAFF REPORTS

6.A. Approval of Minutes

It was moved by Commissioner Luevano, seconded by Chair Illingworth, and carried 2-0 by roll call vote, to approve the Minutes of the Regular Meeting of June 7, 2022 (Abstained: Commissioner Guerrero and Commissioner Muro).

6.B. Election of Officers

Commissioner Luevano nominated Commissioner Muro for Chair and Commissioner Guerrero for Vice-Chair. Commissioner Muro and Commissioner Guerrero accepted the nominations.

It was moved by Commissioner Luevano, seconded by Commissioner Illingworth, and carried 4-0 by roll call vote, to approve the election of officers.

6.C. Information and Referral Reports

Specialist Rivera presented the June, July, and August 2022 Information and Referral Reports. She explained that the reports reflect the calls staff received regarding resources. Specialist Rivera added that staff is organizing an open house for seniors to provide healthcare services information. Also, she continued that when staff sees an increase in calls regarding specific resources, staff will schedule a lecturer on the topic for the Senior Community.

Chair Muro asked if the Commission receives monthly information and referral reports. Specialist Rivera stated yes, reports are presented on a monthly basis.

It was moved by Commissioner Illingworth, seconded by Commissioner Luevano, and carried 4-0 by roll call vote, to receive and file the June, July and August 2022 Information and Referral Report.

6.D. 2022 Whittier Scholarship Program-Sponsored by Athens Services and Republic Services

Secretary Santana provided a brief overview of the Trash Hauler Scholarship Program. She stated that Athens would issue five (5) scholarships and Republic Services would issue four (4) scholarships. Each scholarship is for \$500.00.

Chair Muro asked if the scholarship is strictly an essay contest. Secretary Santana responded yes; students submit their essays via Google Forms. Commissioner Luevano asked if we could carry over the unused scholarship money from previous years. Secretary Santana explained that we would need to amend the agreement with the trash haulers. However, she added that staff would look into amending the agreement.

Commissioner Illingworth asked if staff cross-checked the applicant's information regarding their residence and service area. Secretary Santana stated yes. Vice-Chair Guerrero asked if a student lives in the Athens services area, are they only able to receive the scholarship from Athens. Secretary Santana responded yes. Commissioner Muro asked for the highest number of submissions received by staff. Secretary Santana stated that fifteen (15) essays were the most we have received. Vice-Chair Guerrero asked if students only had the option to submit an essay or if they could submit a video essay.

Commissioner Illingworth stated that having the students submit video essays is a good idea. Chair Muro asked if the essay was open to all students regardless of their legal status. Secretary Santana stated yes, so long as they attend a high school in Whittier.

Chair Muro asked if we have access to the past essay prompts. Secretary Santana stated that we have past essay prompts that were not utilized. Manager Hamilton continued that we recently presented an essay prompt relating to food waste. She asked the Commission what specific criteria they would like to ask for the video submissions. She stated that the criteria could specify that the students implement what they say in their video essay by depicting it in their video submission.

Commissioner Luevano suggested asking the service companies to invite the students over to show them what they do and stated that the composting essay prompt was a good topic. Secretary Santana stated that we could gather a list of questions to present to Commissioners. Also, she added that we could reach out to the service providers to organize the tours of their facilities. Chair Muro asked if we have a rubric for grading already in place. Secretary Santana stated yes and added that we could bring it before the Commission for review.

Commissioner Illingworth suggested that we send out a public service announcement to ask for video essay submissions which we could showcase on social media to address the essay message to the public. Secretary Santana stated that we could bring back details to the Commission.

Commissioner Illingworth asked if we could have a school familiar with filming and media to give students advice, which they can implement for their video submission. Secretary Santana stated that we have a green room students could utilize. Commissioner Illingworth added that we could send out a public service announcement for selected individuals related to their essay topic. Manager Hamilton added that we could write a script for each service provider.

Commissioner Muro stated that her husband is a teacher and that his students use their iPad to film their projects, and the product submitted always looks good. She added that using the green room would also be a great experience for students looking into majoring in media or journalism.

It was moved by Commissioner Luevano, seconded by Commissioner Illingworth, and carried 4-0 by roll call vote, to receive and file the 2022 Whittier Scholarship Program and have staff return with additional information.

6.E. Volunteer of the Year

Secretary Santana updated the Commission on the volunteer of the year program. Applications are sent to all nonprofit agencies allowing them to nominate volunteers that have assisted their agency. In the past, we have received applications from many agencies, both new and old. We gather applications, which are brought to the Commission for review and selection.

Commissioner Illingworth asked if the hours of service being considered are for 2021 or 2022. Secretary Santana responded that the hours of service being considered are for 2022. Commissioner Illingworth added that he likes the April date for the award ceremony as well.

It was moved by Commissioner Illingworth, seconded by Commissioner Luevano, and carried 4-0 by roll call vote, to accept the recommendations made for the Volunteer of the Year application and to schedule the reception after receiving Council feedback.

6. SECRETARY'S COMMENTS

Secretary Santana thanked incoming and departing Commissioners for serving on this Commission. After-school programs are up and running. Staff will operate sports camps which are around the corner. Adaptive Recreation will resume in-person activities. We have several ongoing park projects. Council approved the \$4 million to renovate the Senior Center. Also, the Homeless Consortium will be hosting a meeting on October 18 at Parnell Park beginning at 5:30 p.m. Staff will get the information to the Commission.

Commissioner Luevano asked if the Commission is still responsible for the homeless initiative. He also asked if the agencies who received funding would come and speak before the Commission to ask questions as we begin the application process. He asked if this could be an agenda item for the next meeting. Secretary Santana said we could invite past recipients to speak in front of the Commission. Commissioner Illingworth stated that for the sake of time, we could go with the groups that receive the most funds and have them speak in front of the Commission.

Vice-Chair Guerrero asked if they would be coming in person. Commissioner Luevano stated that it would be beneficial to see nonprofits present their reports before the Commission. He also asked if we could create an agenda item to discuss the fact that Council has not given the Commission direction yet. Secretary Santana stated that Council is determining what direction they will provide.

Chair Muro asked if the Commission may evaluate what was obtained from the plan since it's been a while since implemented. Secretary Santana said yes, and we will add it to the agenda.

7. COMMISSIONERS' COMMENTS

Commissioner Illingworth thanked staff. During the Summer Camp staff was amazing. They made everything fun. He also thanked outgoing Commissioners and the graciousness provided.

Vice-Chair Guerrero stated he is honored to be here. He is learning so much. He added that it's a blessing to see people coming together and see this kind of meeting. He is excited to see how they will impact the community and recalls participating in the scholarship program.

RECOMMENDATION

Review previous scholarship essay prompts, the grading rubric and discuss criteria for possible video essay submissions.

BACKGROUND

Included in the contract service agreements with Athens Services and Republic Services is the requirement to have a Scholarship program for students that are Whittier residents within one of the service providers' areas. Annually, the Social Services Commission reviews the criteria for the program prior to application distribution.

Each year five (5) scholarships of \$500 each for college-bound students living in the Athens services area and four (4) scholarships of \$500 each for students living in the Republic Services area are made available. To promote the scholarship program local High Schools spread the information on campus and Staff shares the opportunity on the City's social media platforms.

DISCUSSION

At the request of the Commission staff compiled a list of past essay topics reviewed by the Commission since 2019 (Attachment A) and the grading rubric listed on the Scholarship Program Criteria (Attachment B) for their review. Also, the Commission will discuss the criteria for possible video essay component should they want to make that an option.

Trash Haulers Scholarship Program Essay Prompts

- Waste, and how we choose to handle it, affects our local City, including the air, water, land, plants, and man-made things. Waste management is so important because...?
- Discarding waste in unsafe ways and in non-approved places can endanger our local environment. Discuss how residents can become more responsible for what we throw away and the impact this waste may have on our local environment.
- Recycling saves natural resources, contributes to improved air and water quality, and reduces the need for landfill expansion. Describe a strong and successful residential recycling program to "save" landfill space, which discusses ways to recycle, reduce, and reuse our residential waste.
- What could you do to voice your opinion about solid waste issues in your community?
- Everyone produces some waste, but you don't have to be a "super consumer."
 One way to help the issue is to think about the goods, services, and activities you
 buy or support. In what ways do they contribute to the solid waste problem? How
 could you purchase and dispose of items in other ways that would generate less
 trash?
- What is the most important issue facing the environment today?
- Who do you think is more responsible for pollution, individuals or the government? Explain.
- Is recycling truly beneficial for the environment?
- Is recycling the best management option? What other options are there?
- Write an influential letter to the City Council asking them to take an action to reduce the CO2 emissions and residential waste in the city. Discuss what actions you want the Council to take and reasons why those actions are important.
- How would you balance the need to reduce greenhouse gas emissions, through SB1383, with the desire to help residents and businesses that are already suffering financially?
- * Pretend you are the new Director of Sustainability for the City of Whittier, and it
 is your job to educate 86,000 residents on how to compost their food waste.
 Discuss how you would encourage residents to participate in your proposed new
 program(s) by describing your marketing plan, goals, and measures of success. *
- Contamination in recycling is a big problem. Review the recycling policy of Athens or Republic Services to learn more about contamination. Explain why

- contamination in recycling is problematic and discuss how residents and businesses could improve their local recycling to reduce contamination.
- Research recycling programs in Japan, Germany, and the United States and compare and contrast what differences are used in their respective recycling programs. Which country do you think is most successful at recycling and why? Apply your findings to Whittier.

Scholarship Essay Selection & Review Guidelines

Writing Guidelines:

Essays must be 400 to 500 words in length, typed, double-spaced, 12-point font, and follow MLA formatting. Facts and quotations should be appropriately cited either in the body of the essay or in footnotes using MLA citing format. Entries must be original, unpublished essays written by the contestants.

Submission Guidelines:

Please submit only one essay per student. If selected to receive a scholarship, a picture will be included as part of our media campaign. By submitting a photo, the applicant grants permission to the City of Whittier to use the photograph for advertising purposes.

Please submit your entry and photograph via the Google Forms link **OR** email with the subject "ScholarshipEssay". Include your essay as an attached document.

Following MLA formatting, heading needs to include the following information in the order presented:

- Student's Full Name and Name of Legal Guardian
- Email Address and Contact Number
- Home Address
- School Name and Grade Level
- Name of the Trash Hauling Service Provider (either Athens Services or RepublicServices)

Selection of Scholarship Recipients:

The City of Whittier's Social Services Commission will evaluate the essays. Essays will be judged with no identifying information available to the judges. Decisions by the judges are final.

Essays will be evaluated based on:

- Creativity
- Demonstrated passion for the environment
- Inclusion of local sustainability ideas
- Adherence to MLA formatting
- Use of sources and correct citations
- A vision for the future
