1. CALL TO ORDER:

The regular meeting of the Social Services Commission was called to order at 6:37 p.m. on October 4, 2022.

2. ROLL CALL

3. PLEDGE OF ALLEGIANCE

Commissioner Luevano led the Pledge of Allegiance.

4. PRESENTATION – WHITTIER VETERANS CENTER

Rachel Fiore presented to the Commission the services the Whittier Veterans Center provides to fellow veterans. The Library received a grant in 2014 to establish a resource center dedicated to helping veterans and their families. The Veterans Resource Center is open Monday through Friday, 10:00 AM to 2:00 P.M. Resources include education, mental health, transportation, and food. In addition, they provide access to books, DVDs, and pamphlets for various topics like PTSD and managing civilian life after returning from military life.

Commissioner Luevano asked what demographic they see coming in seeking resources. Rachel responded that they primarily see veterans from the Vietnam era who will inquire about benefits for their spouses after they are gone. However, as of the last two to three years, they have seen a bit more veterans from the Afghanistan and Iraq war come in seeking information about the college fee waivers and benefits.

Chair Muro asked if the Veterans Resource Center helps veterans obtain DD214 forms and whether the resource center gives presentations on their services to other

local organizations. Rachel responded that they do assist veterans in obtaining a DD214 form. She added that the Veterans Resource Center mostly hands out flyers and answers questions at events hosted by the City of Whittier or City of La Mirada. However, they are open to presenting more about the services they offer.

5. PUBLIC COMMENTS

No public comments were received.

6. STAFF REPORTS

6.A. Approval of Minutes

It was moved by Commissioner Luevano, seconded by Vice-Chair Guerrero, and carried 3-0 by roll call vote, to approve the Minutes of the Regular Meeting of September 6, 2022 (Absent: Commissioner Illingworth).

6.B. Information and Referral Reports

Specialist Rivera provided the month of September I & R report, 139 calls were received. The majority of calls were for financial assistance. Although we continue to get calls for transportation, there was a reduction in calls for COVID-related information. Low-cost housing calls have gone down as well.

It was moved by Commissioner Luevano and seconded by Vice-Chair Guerrero and carried by a 3-0 roll call vote to receive and file the information and referral report for the month of September. (Absent: Commissioner Illingworth)

6.C. Athens and Republic Services Scholarship Program

Chair Muro asked if students may only answer one prompt or if they have the option to choose from different questions. Secretary Santana responded that there is only one essay question. Chair Muro asked if there is a rubric the Commission can utilize to grade the scholarship essays. Secretary Santana referred Commissioners to attachment B, which lists the criteria the Commission considers: creativity, passion for the environment, the inclusion of local sustainability ideas, adherence to MLA formatting, use of sources and correct citations, and a vision for the future. Chair Muro asked if there was a scoring sheet. Secretary Santana stated there is no scoring sheet to grade the Scholarship Essays.

Commissioner Luevano asked if we are still talking about accepting video submissions. Secretary Santana stated that the Commission asked at the previous meeting to discuss criteria for potentially accepting video essay submissions and can proceed if the Commission chooses to. Vice-Chair Guerrero suggested that the Commission table the video essay submission consideration to a later time and focus on strengthening the written essay. Chair Muro asked for the Scholarship Essay timeline. Secretary Santana stated that we hope to present scholarships in May before students graduate. The

award reception follows shortly after the Commission selects Scholarship Essay Winners.

Secretary Santana directed the Commission to the list of past essay questions. The Commission reviewed the questions and selected the following question for the 2022-2023 Scholarship Essay: "Pretend you are the new Director of Sustainability for the City of Whittier, and it is your job to educate 88,000 residents on how to use the new food waste container. Identify your plan to increase the use of the new food waste container and describe your marketing plan, goals, and measures of success."

Chair Muro asked why the criteria asks students to meet MLA formatting. Secretary Santana stated that the MLA criteria requirement ensures a consistent format in the essays submitted. Chair Muro asked if there was any way to add a scoring sheet. Secretary Santana stated yes, that is something we can do. Commissioner Luevano suggested removing MLA formatting on the grading rubric because there have been students who received grant money but did not abide by the MLA formatting. Commissioner Guerrero agreed that MLA formatting should be removed from the grading rubric as the essay's contents and impact should be the focus when grading. Vice-Chair Guerrero and Commissioner Luevano suggested replacing "demonstrated passion for the environment" with "relevance, social and environmental impact." Chair Muro suggested adding, "if outside sources are used, you must cite appropriately."

It was moved by Commissioner Luevano, seconded by Vice-Chair Guerrero, and carried by a 3-0 roll call vote to accept question as designed by the Commission, exclude the video submission and table it for next year, and the addition of a scoring component. (Absent: Commissioner Illingworth)

7. SECRETARY'S COMMENTS

Secretary Santana updated the Commission on the homelessness plan question presented by Commissioner Luevano. She stated that staff has not received direction from City Council on the homelessness plan. Once Council is ready to direct us, we will update the Commission.

Manager Hamilton updated the Commission on upcoming events. On October 15, 2022, Family Movie Night showing Casper the Friendly Ghost will begin at dusk. We will also have booths with games, face painting, and food vendors. Earlier in the day, we will be hosting Chalktastic in front of City Hall from 9:00 AM to 12:00 PM. We are partnering with the Whittier Community Foundation to host the 13th Annual Whittier Spooktacular 5K Run/Walk on October 29, 2022. The kid race begins at 7:30 AM, and the big race begins at 8:00 AM. Finally, Adaptive Recreation is bringing back in-person dances, the first being Friday, October 21, at Parnell Park.

Secretary Santana added that we will be hosting a Senior Open Enrollment fair this month at Parnell Park. We intend to help seniors navigate through this difficult process. Vendors will be present to assist seniors with their forms and questions. We

also applied and received a grant through Janice Hahn's office, which allows us to purchase turkeys to give to families and seniors for the holidays. In addition, we partnered with the National Charity League. Moms and daughters who volunteer will decorate the turkey dinner boxes.

8. COMMISSIONERS' COMMENTS

Commissioner Luevano stated that about a year or two ago Council contracted out with a non-profit to help with the loitering around the City. Secretary Santana stated that it was City Net. He asked if we could ask them to make a presentation for the Commission. He added that he had seen more activity in the morning. Secretary Santana stated yes, we could have City Net present.

Chair Muro thanked staff for making her transition into the Commissioner smooth.
