1. CALL TO ORDER:

The regular meeting of the Social Services Commission was called to order at 6:37 p.m. on April 4, 2023.

2. ROLL CALL

3. PLEDGE OF ALLEGIANCE

Secretary Santana led the Pledge of Allegiance.

4. PUBLIC COMMENTS

There were no public comments.

5. STAFF REPORTS

5. A. Approval of Minutes

It was moved by Commissioner McDonnell, seconded by Commissioner Illingworth, and carried by a unanimous vote to approve the regular meeting minutes on April 4, 2023.

5. B. Information and Referral Reports

Information and Referral Specialist Rivera stated 275 calls were received in the month of April. She added that staff continues to receive tax preparation and Dial-A-Ride calls. Other calls received pertain to senior housing calls for both City and County, veteran services, and home repairs due to the rainy weather. We were able to extend tax assistance for two additional weeks to allow us to

assist more seniors with tax preparation. Senior Services also hosted a Transportation Resource Fair. Vice-Chair Luevano asked if staff had received gas utility complaints about their bill increase. Specialist Rivera responded that we hand and recommend callers contact their utility service provider, who can inform homeowners of programs available or organizations that can assist with the bill. There are home improvement grants that can help customers with their accounts. Commissioner McDonnell asked if a citizen cannot afford to pay for their groceries due to high utility bills, are citizens referred to programs like SNAP. Specialist Rivera stated that we connect citizens to programs like CalFresh, SNAP, food banks, interfaith food centers, churches, and other organizations offering food assistance programs.

It was moved by Commissioner Illingworth, seconded by Commissioner McDonnell, and carried by a 3-0 vote to receive and file the information and referral reports for March 2023.

5. C. 2023 Whittier Scholarship Program-Sponsored by Athens and Republic Services

The Commission discussed Aidan Chaidez's essay submission. Vice-Chair Luevano stated that the composting steps listed in the essay were reasonable and that the idea of composting in backyards was also clever. He asked how many applications the Commission could move forward for Athens. Secretary Santana responded that the Commission could forward five scholarship applicants for Athens Services and three for Republic Services. Vice-Chair Luevano stated he would like to move Aidan Chaidez's submission forward. Commissioner Illingworth said he would have liked to have seen more citations across the board, but good ideas were proposed to promote local composting and recycling. Commissioner Illingworth stated he would like to move the submission forward. Commissioner McDonnell noted that she liked their concept of a local community compost bin and training sessions. She supports moving the submission forward. Aidan Chaidez's scholarship essay submission will be moved forward.

Secretary Santana introduced the second essay by Emily Aragon. Commissioner McDonnell stated that she liked the idea that the student said that residents would get a discount on their waste bill after completing one year of participation because it is a huge incentive. She liked the idea of partnering with the students and creating a composting hub in Whittier. She added that starting involvement at the high school level is great because they are a very passionate group that has come to realize they are the ones who will inherit the environment. She stated that she would like to move this essay submission forward. Commissioner Illingworth supports moving the submission forward and finds it important when we get the youth involved. Vice-Chair Luevano supports moving the essay submission forward. Emily Aragon's scholarship essay submission will be moved forward.

Secretary Santana introduced the third essay by Noah Cortes. Commissioner Illingworth thought the essay was well organized and liked the idea of using

social media because that is how teens communicate. Commissioner McDonnell stated that she liked how they thought the program through by the extent of needing frequent pickups in the summer. The student sees a problem and addresses it. She also liked the education components and the different phases, including that residents will be given a 10-gallon compost bin for their household if they attend a workshop. She supports moving the submission forward. Chair Luevano recommends moving the submission forward. Noah Cortes's scholarship essay submission will be moved forward.

Secretary Santana asked the Commission what applications they would like to move forward for Republic Services. The Commission discussed Evan Nasser's essay submission. Vice-Chair Luevano stated that the essay stood out to him because the student discussed educating teens and changing the behavior of adults. He supports moving the submission forward. Commissioner McDonnell acknowledged the poem in the essay and supports moving the essay submission forward. Commissioner Illingworth stated that he liked how the student mentioned SB133's new law in relation to the prompt. He supports moving the essay submission forward. Evan Nasser's scholarship essay submission will be moved forward.

Secretary Santana introduced the second essay submitted by Kristen Advincula. Commissioner McDonnell stated that she liked the idea of connecting with younger residents via social media, and that food waste is discussed as a valuable resource. She supports moving the essay submission forward. Vice-Chair Luevano stated that he supports moving the essay forward. He said that he liked how the student wrote about educating the residents and building excitement around composting. Commissioner Illingworth supports moving the essay submission forward. Kristen Advincula's scholarship essay submission will be moved forward.

Essay number three submitted by Lucas Gallegos was introduced to the Commission by Secretary Santana. Commissioner McDonnell liked the idea of having pictures and descriptions on the bins and how specific the student got about educating the public. The student also included measurable goals as well. She supports moving the essay submission forward. Commissioner Illingworth liked that the educational materials would be provided in both English and Spanish as well and that they would share updates on the progress of the program. He supports moving the essay submission forward. Vice-Chair Luevano supports moving the essay submission forward. Lucas Gallegos's scholarship essay submission will be moved forward.

It was moved by Commissioner Illingworth, seconded by Commissioner McDonnell, and carried by a 3-0 vote to move all scholarship submissions forward.

5. D. COVID-19 Non-Profit Recovery Grant Applications FY 2022-23

Secretary Santana discussed the cumulative average scores administered by the Commission, which ranked the agencies as follows:

13. The Ozzy Foundation
14. The Whole Child
15. CAPC, Inc.
16. Cross Point Christian Church

Vice-Chair Luevano asked if we are determining to fund the average scores. Commissioner McDonnell asked if the proposed allocation is based on the average amount. Secretary Santana stated the amounts are averaged out to provide a starting point for the Commission. She added that the averages are provided based on the Commission's recommendations. She continued that the Commission could decide to allocate funding differently. Commissioner McDonnell noted that the Commissioners agreed on funding for two agencies, the Boys and Girls Club and L.A. CADA. The Commission recommended funding the Boys and Girls Club at \$20,000 and L.A. CADA at \$15,000.

Secretary Santana directed the Commission's attention to the Whittier Historical Society, another agency the Commission agreed on. Vice-Chair Luevano asked if they should recommend funding the average amount. The Commission recommended funding the Whittier Historical Society \$26,620.

Vice-Chair Luevano recommended discussing the agencies that were recommended not to fund. He began with the Cross Point Christian Church. He recommended not funding them because their application was incomplete. Commissioner Illingworth stated that the application proposed funding the church as opposed to a program or project. Commissioner McDonnell initially recommended funding the church because she was impressed by the fact that both pastors went without income during the pandemic. She looks at what agencies are doing, like taking cuts themselves. She added that although they were all over the board, the church provided food to the community during the pandemic, which was a need. Vice-Chair Luevano listed the missing documentation from their application. However, he would be willing to reconsider.

Commissioner McDonnell stated that she was confused by the statement of adverse conditions because some agencies stated there were no findings, and others submitted letters stating there were no adverse findings. She asked if

the agencies received an explanation as to what they needed to do for that form. Secretary Santana stated that the agencies needed to show that COVID-19 affected them negatively. ARPA requirements state that agencies must show an adverse effect. She continued that agencies were required to show the extreme impact on their agency's ability to serve and how they are bouncing back from that adverse effect. Commissioner McDonnell stated that the agency did not explain or show any adverse effect. Secretary Santana stated the agencies were supposed to show they were seriously in need of funds to regroup after those adverse conditions they suffered, and this is a way they are going to get back on track.

Vice-Chair Luevano stated that Cross Point Church did not submit that they have operated for three years in Whittier. He added that there was some information provided, but he thinks they were in transition during year one into the church. Commissioner Illingworth added he also recommended to not fund because of the incompleteness of the application. Commissioner McDonnell stated she is comfortable not funding Cross Point Church but would like to provide feedback. She stated that although she would have liked to provide support, their application was all over the place. The Commission recommended to not fund Cross Point Church.

Vice-Chair Luevano initially recommended not funding Regency Church because they were missing a statement indicating that they did not need to file taxes. He added he is willing to reconsider. Commissioner Illingworth stated that he scored Regency Church lower because they did not address the negative impact of the pandemic and their ability to complete the program within 12 months. Commissioner McDonnell stated that the church took measures to cut back before cutting down its services. Commissioner McDonnell recommended funding Regency Church at \$5,000. The Commission recommended funding Regency Church at \$5,000.

Commissioner McDonnell initially recommended not funding the YMCA of Greater Whittier because of the amount they requested. She added that the funding available was the same as their ask, which she understands is necessary from a fiduciary standpoint. Commissioner McDonnell asked if a budget was submitted. Vice-Chair Luevano stated that he recalled them discussing their budget in the application. Commissioner McDonnell asked for the average funding amount calculated. Secretary Santana stated that the average amount calculated totaled \$13,586.67. Commissioner McDonnell asked if the agency requested \$250,000 would \$13,586.67 get them to their goal or potentially sit untouched until the goal was met. The Commission recommended not funding the YMCA of Greater Whittier.

The Commissioners began to discuss how much to fund REACH. Vice-Chair Luevano asked whether the application required agencies to be headquartered in Whittier. Secretary Santana stated yes, agencies are required to be headquartered in Whittier to qualify for funding. Vice-Chair Luevano stated that he noticed two agencies were not headquartered in Whittier. Secretary Santana stated that the agencies not headquartered in Whittier do not qualify for funds.

If the agency is headquartered in Santa Fe Springs, then it must request funding from that city. L.A. CADA and REACH do not meet the headquarters requirement and will not be considered for funding.

The Commission recommended funding Whittier Area Literacy Council \$7,440. Commissioner McDonnell stated that they are a great organization operated by retired teachers and volunteers. Their work has helped raise the children's reading scores.

Commissioner Illingworth recommended funding St. Mary of the Assumption Catholic Church \$16,000. Vice-Chair Luevano stated that he is comfortable funding the church. He added that he liked their application and provided significant documentation to show proof of operational history. Commissioner McDonnell stated that they made cuts to various sites to keep their food program open. The Commission recommended funding St. Mary of the Assumption Catholic Church \$16,000.

The Commission recommended funding Whittier Area First Day \$50,000. The Commission recommended funding SPIRITT Family Services \$25,000. The Commission recommended funding Nehemiah Project LA, Inc. \$25,000. Commissioner Illingworth commented he was concerned about the Women's and Children's Crisis Shelter's ability to complete the work in 12 months otherwise, it was a good application. The Commission recommended funding Women's and Children's Crisis Shelter \$10,000.

Commissioner McDonnell initially recommended not funding The Ozzy Foundation because she was trying to make the numbers work and knew they had received funding from the Social Services Grant Funding Program. She stated that she was open to funding them because the need for their services is great. Commissioner Illingworth added that The Ozzy Foundation services a niche part of the community. The Commission recommended funding The Ozzy Foundation \$2,500.

Commissioner McDonnell stated she was concerned that The Whole Child did not provide a breakdown of their budget, but they are a strong organization. Commissioner Illingworth recommended funding The Whole Child \$10,000. Vice-Chair Luevano suggested recommending funding for other agencies and revisiting The Whole Child.

Vice-Chair Luevano stated that CAPC, Inc. did not provide a clear goal or trackable mechanism. He stated he would be comfortable funding the agency with \$10,000. Commissioner McDonnell commented that the agency is undergoing changes. The Commission recommended funding CAPC, Inc. \$10,000.

The Commission revisited the Whittier Historical Society and recommended funding them \$29,040. The Commission revisited St. Mary of the Assumption Catholic Church and recommended funding them \$ 19,200. The Commission revisited Whittier Area First Day and recommended funding them \$60,000. The

Commission revisited SPIRITT Family Services and recommended funding them \$35,000. The Commission revisited Nehemiah Project LA, Inc., and recommended funding them \$41,000. The Commission revisited the Whole Child and recommended funding them \$10,000. The Commission revisited the Women's and Children's Crisis Shelter and recommended funding them \$10,820.

It was moved by Commissioner Illingworth and seconded by Commissioner McDonnell, and carried by a 3-0 vote to move forward with the funding recommendations for the COVID-19 Recovery Grant Funding Program.

6. SECRETARY'S COMMENTS

Secretary Santana stated that Students Run Whittier is now open through May 25. She added the Public Safety Expo and Kiddie-K Fun Run will return on May 20th. Spring swim lesson registration opens on April 17. Kid's Sports Night will provide an opportunity for kids to have fun. We will be hosting a Keep Whittier Prettier Clean-up Day Pop-up event on April 22, at Murphy Ranch Trailhead, Palm Park Trailhead, and Hellman Park Trailhead. The rubber duck races will return this May Youth Services Day Camp registration opens on April 24, at 9:00 a.m., and Summer WYN Club registration opens on May 1, 2023.

During this year's Budget Study session, we will present updated Social Services Grant Funding Guidelines and criteria to City Council. We would like the Commission to provide suggestions for the application at the next regular meeting. Secretary Santana stated that we will ask the Commission what kind of questions would be more relevant to ask and whether there should be a focus.

Secretary Santana thanked the Commission for evaluating all the Social Services Grant program funding applications, as it is time-consuming. Vice-Chair Luevano asked when Commissioners will receive the Volunteer of the Year script. Secretary Santana stated that we will send out the script as soon as possible.

7. COMMISSIONERS' COMMENTS

Vice-Chair Luevano thanked everyone.

Subject: Social Services Grant Funding Program

RECOMMENDATION

Discuss and recommend changes to the Social Services Grant Funding program.

BACKGROUND

The City of Whittier has supported local nonprofit agencies providing resources to the Whittier community through the annual Social Services Grant Funding process. The adopted budget includes \$176,516 from the General Fund to support local social service projects financially. The Social Services Commission annually reviews applications to provide recommendations to the City Council for distributing these funds. The opening of the Grant Program is made available through press releases and mailings to interested agencies. For the past several years, the criteria focus has been on agencies providing resources for persons experiencing homelessness, including providing housing and addressing the needs of families.

DISCUSSION

The Social Services Commission will review the Social Services Grant Funding Program and make recommendations for City Council's consideration.

Social Services Grant Funding Application - 2022/23

The Social Services Commission was established by the City Council to study and make recommendations regarding matters pertaining to the social services needs of the community. The City Council's philosophy is that the City should not provide direct social services, but utilize City funds to support social service agencies providing much needed services to our homeless community and to those agencies providing general social services to our community at-large.

To accomplish this goal, the Commission is now inviting non-profit organizations, with innovative ideas, to apply for funding in two separate focus groups. Total grant funds available: \$176,516.00 for the 2022/23 Fiscal Year.

Grant Award Focus Groups:

Focus Group #1: 75% or \$132,387.00 available to non-profit organizations who serve those who are experiencing homelessness, Whittier families or Individuals at risk, and/or Whittier families or individuals that are food insecure.

Focus Group #2: 25% or \$44,129.00 available to non-profit organizations who serve our Whittier residents with social service needs, other than those described in Focus Group #1.

Applicants should take special care to read all instructions before completing the attached application. Please carefully consider which funds you are applying for, to ensure alignment between your project/program and the intent of the focus group.

APPLICATION INSTRUCTIONS
