- Adjustment to number of residents served vs. only percentage.
- Decision points for one application.

Preparatory meeting language: "must attend" versus "highly recommended".

• Council approved "must attend" language.

Any nonprofit in need of funding is able to submit an application.

- Core groups submit year after year.
- Majority funded served Whittier focusing on homelessness, food insecurity, and childhood obesity.

Recommendations:

- Clear timeline.
- No focus: leaving focus open provides an opportunity to widen the process.
- Factor number and percentage of Whittier residents served into scoring.
- Application to include "no regranting of funds" language, project evaluation description, and population that the agency serves.
- Research to discover trends: senior and youth in need, homelessness, and technology.

It was moved by Commissioner McDonnell, seconded by Commissioner Illingworth, and carried 4-0 to take and include recommendations and adjustments for areas of focus for the Social Services Grant Funding Program.
