#### **RECOMMENDATION**

#### **BACKGROUND**

The Los Angeles County Supervisors office has sponsored the Community Street Banner Program for several years. Each year staff receives hundreds of submissions for this popular art program. From the submissions, 120 artists are selected to recreate their submitted designs onto a seven or nine-foot banner that hangs for three months on Whittier Boulevard and in front of City Hall on Penn Street.

#### **DISCUSSION**

The Street Banner Program subcommittee, consisting of Commissioners Pam Korporaal and Christopher Rubalcaba, met on October 23, to discuss and review twelve possible theme options and logos for the 2024 banner program. Commissioners Korporaal and Rubalcaba provided feedback and narrowed down the selections. Four theme options are presented, each accompanied by a corresponding logo concept. These themes aim to inspire creativity and engage participants in a meaningful way.

#### Tentative timeline:

- Early January 2024 Promotion of program begins.
- February 23 Submissions due.
- March 4 Subcommittee selection.
- March 14 Selected artists notified.
- June 11 Banner Reception.



Subject: Visual Arts and Chalktastic Updates

#### **RECOMMENDATION**

Receive and file visual arts update.

#### **BACKGROUND**

#### Visual Arts

This year-round program exhibits local artists at City Hall and Parnell Park with each exhibit lasting six weeks. A Call to Artists is put out each year to the community to recruit artists. Ten artists were selected to exhibit their work for the 2023 calendar year and into the early months of 2024.

#### **DISCUSSION**

#### Visual Arts

A Call to Artists will open to the public in December for the remainder of the 2024 schedule. The submission deadline is February 2, 2024. The Visual Arts subcommittee will meet the third week of February to select artists to be considered for the 2024 schedule. If enough submissions are not received, a second Call to Artists will be scheduled later in the year to fill the slate for the second half of the year.

#### Chalktastic

On Saturday, November 18, the front of City Hall was turned into a community art display at the annual Chalktastic program. Over 160 artists pre-registered for the event and despite the early morning inclement weather, 118 artists showcased artistic skills ranging from seasonal themes, cartoon characters, and landscapes. Prizes were awarded for first and second places in each age category and a People's Choice Award that was selected by attendees casting votes for a favorite art piece.

Professional chalk artist, Stacy Moffatt, returned with a whimsical welcome message in the center of the event footprint. This year she added a "community coloring book" that allowed all in attendance to color in. Also returning was chalk artist, Amanda Harris, of Wandering Brushes who created a 3-D fall mural.
