5. STAFF REPORTS

5.A. Approval of Minutes

5.B. Election of Officers

6. SECRETARY COMMENTS

- Committee down from seven to five members, per City Council.
- E-mail sent to Wes Murray thanking him for Committee service.
- Meeting with City Manager Saeki today regarding the AIPP Master Plan. Revised plan will be sent to Council for agenda placement tentatively after the first of next year. Red-lined copy going to lawyers to confirm up to date.

Dorland Park Update: Not an official agenda item (update only).

- 10/24: Branding initiative discussed at Council meeting. "Welcome" signs are part of the initiative Council is pushing; may not be wanted at Dorland.
- Committee selected Dorland for "Welcome" sign and is pushing this piece.
- Consider adding as a future agenda item whether an art piece is still desired at Dorland. Previously listed sites can be brought back on agenda for consideration of what to do in the interim.
- RFP is ready; was presented to Commission but put on pause for Council.
- Dorland RFP moving forward, but not guaranteed. All Committee information will be sent but may be tabled until after the branding initiative.
- Branding initiative timeline is 6-9 months after City Council adopts the plan; first rough draft was brought to Council. Currently, there is no visual of the Master Plan.
- Member Hahn inquired if re-branding is part of Greenleaf Promenade. Manager Hamilton advised she wasn't sure how much of the promenade since the Businesses have their own signage.
- Manager Hamilton will check if the preliminary map including "Welcome" sign placement can be shared with the Committee (to gauge areas least effected by branding).
- Re-branding information that became public knowledge at the 10/24 meeting can be provided for Committee viewing.
- Current funding amount can be provided for consideration of increasing the number of art pieces.

Banner Program

- Cultural Arts Commission discussed logos (coming out in December).
- No theme selected yet; subcommittee is working on.
- 21st year of program; all ages participants.
- Will line Whittier Boulevard and Penn Street in front of City Hall.

AIPP Website and Postcard

Postcard provided to Committee; can also be downloaded from webpage. Management Analyst Diamond reviewed the website and updates for the Committee.

- Received feedback wanting more photos unique to Whittier.
- Committee Member recommended or newer pieces chosen for landing page photos; can be changed upon recommendation.
- Include widgets on page to link postcard numbers to widget numbers on website.
- Dropdown provides art piece and artist information.
- Links helpful to navigate page for specific or comprehensive information.
- QR code: future consideration for a plaque with a QR code if funding becomes available. Code could be cast in metal and link art piece and artist information to our central landing page.

10/28: Spooktacular 5k (14th year of event); over 3,000 runners registered.

11/04: ASkate Event will include a Resource Fair; a foundation that works with people with disabilities will walk through the skate park.

11/18: Chalktastic; People's Choice and age category prizes will be awarded. Chalk artist will draw outlines so people can participate in a different way, if desired.

12/02: Grand Illumination Tree Lighting at City Hall. City Council bought a 26-foot tree and Whittier Community Foundation purchased a 12-foot star for photo opportunities. There community can walk to the Uptown area to the Sonata after.

12/09: Christmas parade.

12/16: Cookies with Santa in gymnasium (cookies, crafts, and activities).

Director Santana out on medical leave and will be back around February.

RECOMMENDATION

Review previous locations considered for placement of public art or consider creating a new potential list of art locations.

BACKGROUND

At the meeting of May 26, 2021, Staff researched and brought back more information on Dorland Park, The Grove, the Uptown parking structure, and the Walnut tree area.

Below is the background information on each initial proposed location:

- Philadelphia Street & Whittier Boulevard green space: This site was brought to the committee in 2020 when all committee members were asked to propose new locations for artwork. There is a sign on the green space, and it is located across from the entrance of the groves at the intersection Whittier Boulevard & Philadelphia Street. It is worth noting that two blocks east of this site is the latest Art in Public Places piece, Solar Tree, that was dedicated in 2019.
- Dorland Park: Dorland Park, newly named in 2017, is located at 10525 Whittier Blvd. that sits just east of the 605 freeway. The area consists of rolling knolls, ninety-three trees, a Welcome to Whittier sign and turf. The parcel of land is unique in that it is separated by Rockne Street and continues to east to Norwalk Boulevard. The land is a passive area with no programming or additional amenities.
- Royal Hybrid Walnut Tree: Planted in 1907 by George Weinshank as a part of an experimental planting for the University of California. In 1958 the State had the park area of 500 feet long graded and sidewalks were installed for the 100 feet along the curbs on both sides of the tree with gravel walkways across the area to protect the tree. In 1959 the Tree was registered as a Historic Landmark. In 1966 the Parks Department entered into an agreement with the State to take charge of

the parkway, installing automated sprinklers and annually pruning, where the hybrid tree resides to this day.

- **Uptown Parking Structure**: The Multi-deck, built in 1964, is located in Uptown Whittier at 6721 Bright Avenue and is owned by the City of Whittier. The parking structure has 8 levels with a capacity for 223 parking spaces.

At the meeting on August 25, 2021, the Committee deliberated on the potential locations for the next art piece, including the intersection of Philadelphia and Whittier Blvd and Dorland Park. Additionally, there was a decision to relocate the Walnut site to a distinct ongoing agenda item.

During the meeting on September 22, 2021, the Committee proposed Dorland Park as the potential location for the art installation, as members believed that a larger site would be more suitable for the art piece.

DISCUSSION

As of October 25, 2023, due to the branding initiative promoted by the Council the "Whittier" art piece at Dorland Park has been put on hold. However, the Committee has three other viable options to explore: the green space at Philadelphia Street & Whittier Boulevard, the Royal Hybrid Walnut Tree, and the Uptown Parking Structure. Additionally, the Committee may explore new locations within Whittier for the installation of a new art piece.

Additional Site Information

Philadelphia Street & Whittier Boulevard green space:

This City site is located across from the entrance of the new Groves development at the intersection Whittier Boulevard & Philadephia Street. It is worth noting that two blocks east of this site is the home of our Solar Tree art piece that was dedicated in 2019.

Dorland Park:

Dorland Park, newly named in 2017, is located at 10525 Whittier Blvd. The park is just east of the 605 freeway. The area consists of rolling knolls, ninety-three trees, and turf. The parcel of land is unique in that it is separated by Rockne Street and continues east to Norwalk Boulevard. The land is a passive area with no programming or additional amenities.

Royal Hybrid Walnut Tree:

This special tree was planted in 1907 by George Weinshank as a part of an experimental planting for the University of California. In 1958 Cal Trans, a state agency, had 500 feet of the park area graded and sidewalks were installed along the curbs on both sides of the tree with gravel walkways to protect the area. In 1959 the Tree was registered as a Historical Landmark. In 1966 the City of Whittier Parks Department entered into an agreement with the State to take charge of the parkway, installing automated sprinklers and continued maintenance of the area.

Uptown Parking Structure:


















