MINUTES ART IN PUBLIC PLACES ADVISORY COMMITTEE REGULAR MEETING CITY COUNCIL CHAMBER, 13230 PENN STREET MARCH 27, 2024 – 4:30 P.M.

1. CALL TO ORDER

The regular meeting of the Art in Public Places Advisory Committee was called into order at 4:32 p.m., in the Council Chamber of Whittier City Hall, 13230 Penn Street, Whittier, California.

2. ROLL CALL

3. PLEDGE OF ALLEGIANCE

Vice-Chair Medina led the Pledge of Allegiance.

4. PUBLIC COMMENTS

No public comments were received.

5. STAFF REPORTS

5.A. Approval of Minutes

It was moved by Chair Rowe, second by Member McCarty and carried by 4-0 vote to approve the Minutes of the Regular Meeting of October 25, 2023 (Absent: Member Martinez).

5.B. Replacement of Art Piece "Freedom"

Manager Hamilton explained that a component of the "Freedom" art piece had been stolen. To address this, we were awaiting action from the insurance company for replacement. However, we were considering seeking approval from the Art in Public Places Advisory Committee to utilize funds temporarily from the maintenance account to replace the missing piece.

Chair Rowe inquired about the theft's details. Manager Hamilton described how perpetrators attempted to steal the bronze piece at night at the York Field Sports Complex. After exhausting multiple saw blades in their attempt, they resorted to digging it out. Discovering it was tethered to 4 ft. of concrete, they abandoned further theft efforts. They then transported the piece in a wheelbarrow to the train tracks, where it was loaded onto a truck. The wheelbarrow and tools were left behind. Manager Hamilton noted this was the first theft attempt on the statue, though theft issues were ongoing in the sports division at York Field Sports Complex, prompting investment in a security system to mitigate such incidents.

It was moved by Member Hahn, second by Chair Rowe and carried by 4-0 vote to recommend the allocation of funds from the Art in Public Places maintenance account to the Cultural Arts Commission to replace the statue. (Absent: Member Martinez)

5.C. Potential Public Art Locations

Manager Hamilton presented various concepts for the art installation planned for the green space at Philadelphia Street and Whittier Boulevard. These ideas included a sculpture, a beacon, the city name, directional elements, urban interventions, and artistic play spaces. After deliberation, the Art in Public Places Advisory Committee showed a preference an art piece similar to the Beacon Light Sculpture. They collectively favored a modern, illuminating, open, and organic design. Member Hahn suggested integrating boulders for aesthetic appeal, while Vice Chair Medina proposed adding a pathway with landscaping to enhance foot traffic around the artwork. Manager Hamilton expressed approval of these suggestions, considering them a promising start. She committed to drafting a Request for Proposal for the next meeting, incorporating these new details.

The Art in Public Place Advisory Committee unanimously agreed on drafting an RFP for a sculpture that similar to the beacon light that was modern, illuminating open and organic for the new location located at Philadelphia Street and Whittier Boulevard. (Absent: Member Martinez)

6. SECRETARY COMMENTS

Manager Hamilton reported that despite the rain, Eggxtravaganza saw a fantastic turnout. We made the decision to transition the event from a \$5 fee to free admission due to the inclement weather. In place of traditional egg hunts, we distributed bags filled with candy-filled eggs and additional treats.

Manager Hamilton announced that PRCS Department was honored with two awards at the California Park and Recreation Society conference. One award recognized our excellence in social media, while the other celebrated Bobby Ruiz as a Champion of the Community for partnering with the City.

Upcoming events include the closing date for beautification award submissions on April 5th, 2024, Wake Up Whittier on April 17th, 2024, and Keep Whittier Prettier on April 20th, 2024.

7. COMMITTEE MEMBER COMMENTS AND CONFERENCE REPORTS

Chair Rowe inquired whether the city could incorporate interactive statues into the revitalization plans for Uptown Whittier.





REQUEST FOR PROPOSALS

Call for Artist

The City of Whittier Art in Public Places Committee is seeking to commission an artist to create an art visually enhance the area in a unique and engaging manner appropriate for the site given the dimensions in a way which the public will interact with the site.

Project Description

A commission of new work that will be modern, illuminating, open and organic, that will be tall enough for drivers to see but not distracting.

Art Criteria

Open to a variety of mediums including but not limited to the following: BRONZE, METALS, CONCRETE, STONE, ALUMINUM, MIXED MEDIA, LED Water Element is NOT Desired.

Project Location Description

The site is at the corner of a busy highway across from the newly redeveloped area in Whittier called The Groves. There is pedestrian, bike and vehicle traffic that

The site is approximately 127ft at its longest part, by 39 ft at its widest part. It is a long and narrow parcel of land with a concrete rectangle at the Northwest side of the parcel. It has electrical access as it used to hold a sign that pointed towards Uptown Whittier.



Budget Expectations

The current budget for this project is \$XXX. The budget must include the artist's design fee, the cost of fabrication, transportation, and installation of the work; as well as travel, insurance, lighting, other complementary elements being proposed, and all other expenses. Any permit fees, drawings, travel costs, consulting, or other expenses will be incurred by the artists and should be anticipated and reflected in the artist's proposed budget. Compliance with all state and local building codes and Los Angeles County standards are required and expected.

Artist Eligibility

This competition is open to all artists experienced in Public Art. Local artists are encouraged to apply. Incomplete submissions will not be considered.

The Art in Public Places Advisory Committee will serve as the selection panel that will review all complete submissions. The Committee will submit finalist(s) to the Cultural Arts Commission for review. Finalist(s) will then be given a \$500 stipend. The Cultural Arts Commission will submit one recommended project to the Whittier City Council for final approval.
