1. CALL TO ORDER:

The Social Services Commission's regular meeting was called to order at 6:33 p.m. on April 2, 2024.

2. ROLL CALL

3. PLEDGE OF ALLEGIANCE

Commissioner Illingworth led the Pledge of Allegiance.

4. PUBLIC COMMENTS

Javier Garcia (6226 Washington Ave), a member of the public, stated that we should consider allowing the public to make comments after every agenda item and not limiting public comments to the beginning of the meeting.

5. STAFF REPORTS

5. A. Approval of Minutes

Commissioner Brauckmann moved, Commissioner Illingworth seconded, and the motion carried 3-0 to approve the regular meeting minutes of November 7, 2023, and the special meeting minutes of January 8, 2024.

5. B. Information and Referral Reports

Information and Referral Specialist Rivera stated the following:

- Received a total of 285 calls for March.
- Received a high number of calls pertaining to taxes.

- Also received a high number of calls pertaining to transportation.
- Received a couple of calls pertaining to Child Protective Services

Vice Chair Luevano asked if Child Protective Services calls are referred to SPA 7. Specialist Rivera stated that we received a call from a neighbor who reported children not attending school. She added that when we receive CPS calls, we direct the caller to contact the school district. Specialist Rivera continued that we also receive calls from caregivers who notice something off with a child. However, CPS calls are rare. Commissioner Illingworth noted a correction on page 4 of 9. The October report should read "In the month of October."

Commissioner Illingworth moved, Commissioner Brauckmann seconded, and the motion to receive and file the information and referral reports from August 2023 to March 2024 was carried by a 3-0 vote.

5. C. 2023 Whittier Volunteer Recognition Program

The Community Services Manager provided a brief background on the Volunteer of the Year Program. She shared that we received 13 nominations.

The Commission selected the following as Volunteer of the Year award recipients:

- Jan Sprague was nominated by the Assistance League of Whittier.
 Commissioner Illingworth stated that over 20 years of service is quite a history of service.
- Michael and Maxine Gimbel were nominated by the Boys and Girls Club.
 Vice-Chair Luevano stated that 50 hours in the last 20 years is quite a commitment.
- Richard Barrantes was nominated by CAPC, Inc. Vice Chair Luevano stated that 400 hours of service shows he volunteered about 50 days, and he has been a board president since 2021 and filled other positions during his time with CAPC.
- Murphy Ranch Little League nominated Albert Richards. Commissioner Illingworth stated he has seen AL in action over the last couple of years, and he is very well known and agrees with his nomination. Vice Chair Luevano added that Al led the umpire class as well.
- Murphy Ranch Little League nominated Daniel Garibay. Commissioner Illingworth stated that Dan is very dedicated to the league and deserves to be recognized. Vice Chair Luevano stated that what stood out to him is having parents request that he coach their kids, and Dan has put in many volunteer hours.
- Alex Moisa was nominated by the Whole Child. Vice Chair Luevano stated that Alex was once a board president and is in the community.
- Whittier Area Youth Soccer (WAYS) nominated Rudy Aldama. Vice Chair Luevano stated that WAYS is a thriving soccer organization partially due to Rudy.

- Joann Libolt was nominated by the Whittier Art Association and Gallery.
 Vice Chair Luevano stated that he loves the work Joann has put in and has come in with a tremendous amount of experience.
- Ray Perez was nominated by the Whittier Host Lions. All commissioners support this nomination.
- Eugene Aguirre was nominated by Whittier Pony Baseball. Commissioner Illingworth supports this nomination but asked staff to request the agency submit a numerical number of hours served. Secretary Santana stated that it will assist with the biographies as well. All Commissioners support this nomination so long as additional information is provided.
- Wes Murray was nominated by the Whittier Public Library for his assistance with the Veteran Resource Center. Commissioner Illingworth stated that Mr. Murray's never-missing shift is impressive because it shows that he is reliable. All Commissioners support this nomination.

The Commission did not select the following nominees as Volunteer of the Year award recipients:

- Virginia Pierce was nominated by Regency Church. Vice Chair Luevano asked if the number of volunteer hours was provided. Commissioner Brauckmann stated that the application contained insufficient information. Commissioner Illingworth concurred and added that he would have liked to have seen more information. The Commission would like the agency to come back next year and asked that more information be included in the application.
- John Bogdanov nominated by the Whittier Chamber of Commerce. Commissioner Brauckmann stated he was concerned that the number of hours was less than the other applicants. Vice Chair Luevano stated he had reservations because the volunteer work described appears to be the ability to market his business and not so much volunteer work. Although he donated his time, it was to push his business. He felt that the line of philanthropy was not met. Commissioner Illingworth stated that he is torn because our small businesses are so critical to the fabric of our community, and the nominee is assisting chamber activities by supporting other businesses. He recommended that the Chamber come back next year and explain how the nominee's actions support the small business community. Chair Luevano added that it's more about the philanthropic view, and the number of years served on the application did not match the number of years on the biography, which was rather confusing.

Commissioner Illingworth moved, Commissioner Brauckmann seconded, and the motion carried by a 3-0 vote to approve 11 of the 13 recipients for the 2023 Whittier Volunteer Recognition Award.

5. D. 2024 Whittier Scholarship Program-Sponsored by Athens and Republic Services

Community Services Manager Hamilton provided a brief background on the scholarship program. Commissioner Brauckmann asked if all applicants could be approved. Commissioners asked if the remaining funds could be equally dispersed among the selected recipients. Secretary Santana stated we can reach out to the trash service providers and ask if funds can be dispersed equally amongst scholarship recipients.

It was moved by Commissioner Illingworth, seconded by Commissioner Brauckmann, and carried by a 4-0 vote to approve the selected 2024 Whittier Scholarship recipients.

Subject: Social Services Grant Funding Application Review FY 2024-25

RECOMMENDATION

Review and recommend submitted FY 2024-25 Social Services Grant application scores to City Council for consideration.

BACKGROUND

Annually, the City Council dedicates financial resources to support local non-profit agencies in their efforts to provide a wide range of essential services. This year, \$176,516 is available from the General Fund to local non-profits that provide services to residents, with additional attention given to agencies providing mental health services for Whittier residents and agencies serving Veterans.

The Social Services Commission conducts the annual review of submissions to ensure a fair and thorough evaluation of applications. This provides valuable input to the City Council on the equitable distribution of these funds.

At the February 13, 2024, City Council meeting, the Council requested the formation of an Ad Hoc Committee to review the Social Services Funding requirements for the 2024-2025 Fiscal Year.

On June 11, 2024, City Council approved the Ad-Hoc Committees' recommended changes to the Social Services Grant Grading Rubric and the Funding Allocation process. The Grading rubric will now allow agencies located within the City of Whittier to earn additional points on their applications. Agencies that provide resources to Veterans will also receive additional points.

The Funding allocation process will move to a banding system that will place application scores into the following bands:

Band 1	100 – 90 points scored	Eligible to receive up to \$20,000
Band 2	89 – 75 points scored	Eligible to receive up to \$15,000
Band 3	74 – 60 points scored	Eligible to receive up to \$10,000
Band 4	59 & under points scored	Eligible to receive up to \$5,000

The 2024-25 FY application was open to agencies on June 25, 2024. The Social Services Commission received 14 Applications on August 7, 2024, for review and consideration for funding.
