RECOMMENDATION

Review submitted FY 2021-22 Social Services Grant applications and finalize proposed funding allocations to City Council for consideration.

BACKGROUND

Annually, the City Council allocates funds to assist local non-profit agencies with funding for various social services programs with a priority for proposals that have an emphasis on serving our Whittier homeless community, Whittier families at risk, and/or Whittier families that are food insecure. There is \$176,516 available in the General Fund for FY 2021-22 Social Services Funding.

DISCUSSION

24 applications for FY 2021-22 have been received for the Commissions to review. 75% of the allocated funds will be available to Focus Group #1 (19 applications) which are non-profit organizations who serve our Whittier homeless community, Whittier families at risk, and/or Whittier families that are food insecure. 25% of funds will be available to Focus Group #2 (five (5) applications) which are non-profit organizations who serve Whittier residents with social service needs, outside of the focus group one criteria.
